
In 1996, thousands of children and adults benefited from the education and preventive care they received at the Sixteenth Street Community Health Center. The following success stories provide just a few examples of people who are living healthier lives as a result of the services provided to them.

Silvia

Silvia first came to the Sixteenth Street Community Health Center when she was pregnant. During her pregnancy, she was diagnosed with gestational diabetes. Her condition improved after being put on insulin, and she gave birth to a healthy baby boy. After her pregnancy, her diabetes became more severe, she was losing weight and suffering from depression. At the Sixteenth Street Community Health Center, her doctor monitored her closely and put her on new medication. Today, her blood sugar level is excellent, she has gained her weight back and has a positive outlook on life.

The Teran Family

Outreach workers from the SSCHC Lead Outreach Project visited the home of Susanna and Federico Teran. Outreach workers provided education to the parents about lead hazards in the home and tested Nathan age 2 and Elizabeth age 5 for lead poisoning. Nathan's blood lead level was 14 micrograms per deciliter and Elizabeth's 11. Lead levels under 10 micrograms per deciliter is considered normal. As the outreach workers explained to parents, these blood lead levels were not dangerously high, but conditions were such in the home (with chipping paint around the windows) that it was very likely the childrens' blood lead level could rise to dangerous levels. The Teran family took the information they received from the outreach workers and put it to good use as they looked for a new apartment. Six months later, when outreach workers visited the Teran's in a new apartment, Nathan's lead level had reduced to 11 and Elizabeth's to 8. A year later, Nathan's blood level reduced to 5 micrograms per deciliter. The Teran family feels confident that they know how to keep their children safe from lead poisoning wherever they live.

Sixteenth Street Community Health Center offers an array of preventive health services to individuals and families living in the south side of Milwaukee. Because of our multi-cultural population, 77% Hispanic, 5% Southeast Asian, 12% White, 4% African American and 2% mixed, all services are available in English, Spanish, Hmong and Laotian. This section includes service descriptions, total number of people who received services, and a few examples of their impact on our diverse client population from April 1, 1996 to March 31, 1997.

Breast Feeding Support Project: Last year, 204 mothers were provided with Breast feeding support.

Outcome: Ninety one percent of these women were still breast feeding at six weeks post partum.



Environmental Health Project: In 1996, work was completed on a major environmental justice initiative that revealed environmental conditions in the neighborhood which pose health risks to families and children who live in the south side area. Results showed that there were more hazardous waste sites, abandoned industrial sites, and more car and truck traffic than in other areas of the County. Materials were developed to show residents what precautions can be taken to minimize their exposure to these hazards. Sixteenth Street also set up two monitors at the Center with the Department of Natural resources to discover how pollution in the area can affect the health of community residents.

Health Education: Education empowers individuals to make healthy lifestyle choices. Throughout the Center's past fiscal year, over 2,000 women and men attend-



ed nutrition child development, parenting, breastfeeding and child birth classes. For the first time this past year the Center also offered Child Care Teacher certification classes. An additional 1,000 students throughout Milwaukee area high schools were educated and provided with sexual responsibility/pregnancy prevention classes by our Health Educator.

Outcome: Through the Child Care certification program, a total of 41 individuals successfully completed 40 hours of training and are qualified to be employed as child care workers.

HIV/AIDS Case Management: During this past year, the Center's HIV Case Manager monitored 32 HIV positive individuals, making sure they received needed medical care and social services. The Center also provided anonymous HIV testing and counseling sessions to 232 community residents.

Immunization Project: Sixteenth Street is the headquarters for the City-wide Immunization Project. Outreach workers made over 5,000 contacts to families with children under the age of two, and as a result 623 children completed their primary immunization series. Outcome: The number of children immunized increased from 22% in April 1996 to 83% by the end of March 1997.



Lead Outreach Project: During this past fiscal year, outreach workers went door to door and tested 296 children, under the age of six, for lead levels in their blood. Of those children tested, 80% had never been tested, and 19% had abnormal lead levels.

Outcome: As a result of monitoring, follow-up and education to families whose children initially tested at high lead levels, 42% of the children tested normal during subsequent home visits.

Mental Health Services: In 1996 the Center contracted with Catholic Social Services to provide mental health services to our patients. A total of 45 individuals were provided with services to help them deal with complex social and mental health issues. In February, 1997 the Center hired its first mental health counselor. From February through April, fifteen clients have been enrolled in the program.

Perinatal Case Management: This past year, 530 pregnant women were provided with medical care, health education, nutrition counseling and follow-up home care.

Outcome: Of the 406 deliveries that occurred last year, 95% of the babies were born above normal birth weight.



Primary Medical Care: In 1996, 8,636 children and adults received primary medical services from the Center's physicians in the areas of pediatrics, internal medicine, family practice, and women's health. Ninety-Nine chronically ill children were monitored through the Center's Pediatric case management program.

School-Based Wellness Center: During the 1996/97 school year, 365 students made 768 visits to the Sixteenth Street Community Health Center's school-based Wellness Center at South Division High School for medical care and sports physicals. An additional 2,114 visits were made by students to the Clinic for first aid or urgent care related reasons.

Social Services: More than 14,344 visits were made to the Social Services Department. Clients were provided with information and counseling for alcohol and other drug problems, domestic violence issues, relationship problems, unemployment, housing, and other social issues.

Outcome: 87% of the women who were identified as using drugs or alcohol during pregnancy tested drug free after receiving treatment, and 95% of their babies were born drug free.

Women, Infants & Children (WIC) Program: 7,941 women and children under the age of five received nutritional education, food supplements and referrals to health services from the State supported WIC program.

Dear Friends of Sixteenth Street Community Health Center:

with this 1996 annual report, we celebrate the diversity of our multi-cultural staff, clients and Board of Directors. This past fiscal year was one of extreme growth for the Sixteenth Street Community Health Center. A total of 88,006 visits were made to the Center by newborns, expectant moms, single parents, children, young adults and older adults. This total represents a 22% increase over the previous year number of visits to the Center. In 1996, the Center teamed up with the other Milwaukee based community health centers to form an Integrated Service Network. The network was created so the Center will be stronger and more competitive in the ever changing health care managed care environment.

The Center's private giving program also got off the

ground. With help from the Center's Board of
Directors, Development Committee, event volunteers, and contributions from
local corporations, foundations, and individuals, the Center's first annual fund raising campaign raised a total of \$438,000. With welfare reform (Wisconsin Works-W2) being implemented in the coming year and the County moving

patients into the community for health care, the Center will see a significant increase in the number of individuals and families in need of health services. To meet these growing needs, in March, the Center purchased facility space located at 1337 S. Sixteenth Street. The expansion was made possible with support from Bank One, Northwestern Mutual Life and the Betty Brinn Foundation. This next year will be one of great change, as the Center will

not only expand into its new building, but also offer Dental services to children and adults who currently do not have access to them. With the ever changing health care, welfare, and managed care environment, it is extremely important that we continue to increase community support of the Sixteenth Street Community Health Center. Thank you to our volunteers, Board of Directors, donors, staff, government leaders, and the men, women and children who receive services at the Center. Together, we will continue helping and healing.
