### **COMMUNITY HEALTH DEVELOPMENT, INC. ANNOUNCES NEW VACCINE PROGRAM AND NEW SCREENINGS**

UVALDE, TEXAS – Community Health Development, Inc. (CHDI) today announced each of its three medical health center sites will participate in a new State of Texas program to provide normally costly adult immunizations at a greatly reduced rate.

Immunizations being offered immediately include those for Hepatitis A and B, Human Papillomavirus (HPV), Meningitis, Measles/Mumps/Rubella, Pneumonia, Tetanus, Varicella (Chicken Pox), and Shingles.

The cost for each vaccine is only an administrative fee of \$5.00. According to information provided by the State, this is a temporary program that should last until the end of the current year. However, vaccines are limited and CDHI urges anyone interested to obtain them as soon as possible.

In order to purchase these discounted vaccinations, a patient must meet one of the following criteria:

- Have no health insurance
- Have health insurance that has no vaccine coverage
- Have health insurance that provides limited or capped vaccine coverage
- Be unable to meet the co-pay or deductible for insurance coverage

Each vaccine has other qualifying factors which may include, among others, a patient's age, gender and environment. For complete information about this special vaccination program, please contact your nearest CHDI health center in Uvalde, Leakey or Camp Wood or call CHDI at (830) 278-7105.

In addition, Our Health / Nuestro Centro de Salud is now offering on-site HIV screening through blood draw as well as Chlamydia and Gonorrhea screenings through urinalysis for all ages. Gardasil, a vaccine for boys ages 9 to 18 for prevention of the HPV virus, is also available.

- **Our Health / Nuestro Centro de Salud**, (830) 278-7105, is located at 200 South Evans Street in **Uvalde** and provides medical care to patients primarily from Uvalde and Zavala counties. Hours of service are Monday and Wednesday from 8:00 am until 7:00 pm; Tuesday, Thursday and Friday from 8:00 am until 5:30 pm; and Saturday from 8:00 am until 5:00 pm.
- **Rolling Hills Health**, (830) 232-6985, is located at Highway 83 and Oakhill Drive in **Leakey** and provides medical care to patients from Real, Kerr, and Bandera counties. Hours of service are Monday, Tuesday, Thursday and Friday from 8:00 am until 5:00 pm; and Wednesday from 10:00 am until 7:00 pm.
- **Canyon Health Center**, (830) 597-6424, is located at 700 Frio Street in **Camp Wood** and provides medical care to patients from Real and Edwards counties. Hours of service are Monday, Tuesday, Thursday and Friday from 8:00 am until 5:00 pm; and Wednesday from 10 am until 7:00 pm.
