More than 500 people attended the event, taking part in health screenings, browsing booths featuring tips on nutrition and health education and participating in exercise demonstrations by local Zumba instructors. HealthNet's Andy Padilla — a health educator known as "the Mexican Richard Simmons" — traveled from Los Angeles to attend the health fair, leading dozens of area children through thirty minutes of fun physical activities on the Ledbetter Park stage. FHCN's Community Relations Representative Linda Duran orchestrated the event with the help of the Community Relations department and a slew of AmeriCorps volunteers. CEO Harry Foster also attended. Afterward, Duran called the health fair "one of the best ever." The next FHCN-sponsored health fairs take place in Woodlake (March 25) and Ivanhoe (April 1).

At Sunday's Cutler health fair, a local resident **Isidro Mendoza**, volunteered to entertain the early arrivals with some rousing Mexican "corridos" – ballads sung in a distinctive, heartfelt manner that had the crowd cheering. After the health fair, **Linda Duran** spoke to Mendoza about writing a song for FHCN. "He said to give him a month and he will work on one," reported Duran. "This is exciting. Mr. Mendoza also said he would be happy to attend – and sing --at the rest of our fairs."

*Huddles a hit at Oak

Following up on Harry Foster's recommendation, shared by FHCN'S CEO in the last edition of the huddle, that a quick, 10-minute team huddle happen at the beginning of every day at every clinical site, **Andrew Myles**, the new clinic manager at Oak, says: "I believe that the huddles are bringing the Oak team closer. Staff feels that it is a great communication tool. It keeps the team aware of any challenges or road blocks that we face each day. They are a good thing." As the organization nears the official roll out date for PCHH, FHCN's Chief Medical Officer **Dr. Steven Palmer** reminds all FHCN team members: "Daily huddles are a key component of the patient centered health home."

*Kudos for dental staff

With the exception of one site, FHCN dental staff surpassed budget targets for the month of February. "Congratulations to all staff -- and thanks for all of your hard work," said Chief Dental Officer **Dr. Henry Cisneros**.

*Anita scholarship application deadline extended to March 19

Family HealthCare Network established the Anita de la Vega Scholarship Fund in 2009 in honor of **Anita de la Vega**, a longtime FHCN clinician who dedicated her life to serving the underserved. Anita's clinical career spanned three decades and in Tulare County, she was widely respected for her tenacity, mentorship, work ethic and commitment to community service. Six \$600 annual Anita scholarships — two for high school students, two for community college students and two for FHCN employees wishing to pursue their educational goals — are awarded each year. *Encouraging news on wait times

FHCN's Quality Improvement Specialist **Eric Medina** reports that during the past month, patients at Woodlake (both medical and dental), Cutler (dental), Three Rivers, Hanford (medical) and Goshen had average wait times of less than 15 minutes! Other highlights from Medina's most recent report:

- All FHCN medical sites combined had an average wait time of 20 minutes, which was the same as January 2012.
- All FHCN dental sites combined had an average wait time of 17 minutes, one minute more than wait times logged the previous month.
- Around the Network during the month of February, 54.81% of medical patients waited 15 minutes or less, an improvement of 0.65% compared to January 2012.
- On the dental side, 63.58% of patients waited 15 minutes or less, which was a slight increase -- 1.14% -- from the previous month.

According to the most recent surveys, long wait times remain among patients' top complaints. "We're operating in an increasingly competitive marketplace and great customer service, including keeping patients informed and comfortable while they are in our waiting rooms, will result in higher patient satisfaction rates," says CEO Harry Foster.

*Sprucing up Woodlake's food pantry

Family HealthCare Network's AmeriCorps team is celebrating AmeriCorps Week this week with a service project beginning today in Woodlake. FHCN's AmeriCorps volunteers will be remodeling the Woodlake Food Pantry, a labor-intensive effort that includes restoring old flooring and replacing lighting and shelving. The facility is the only local food pantry in Woodlake and distributes food once a month to Woodlake residents. Malorie Serrano, FHCN's Community Relations Coordinator for the AmeriCorps team, says that today area officials will participate in a "be an AmeriCorps volunteer for a day" special event. City and county luminaries expected to hoist a hammer or paint brush include Woodlake Vice Mayor Gregorio Gonzalez Jr., Woodlake City Council Member Rudy Mendoza, Chief of Police (and FHCN board member) John Zapalac, Fire Chief Anthony Perez, and Tulare County District 4 Supervisor Steve

Worthley. Also on Wednesday, a representative from NACHC visited Woodlake to participate in the AmericCorps service project, which wraps up Friday.

FHCN CEO Harry Foster and board member Paul Curtis traveled to Washington, D.C. last week to take part in the 2012 NACHC Policies and Initiatives Forum. In addition to attending a number of committee meetings and closed-door sessions with state and national lobbyists, Foster and Curtis also met one-on-one with a bevy of key policymakers and legislators including Congressmen Devin Nunes, Kevin McCarthy and Jim Costa. Foster and Curtis lobbied the lawmakers for their support of President Obama's proposed \$3.1 billion in ongoing funding for community health centers. Congressmen Nunes and McCarthy also promised to attend the grand opening celebration of FHCN's new Porterville dental center when it opens in August. The timing of the annual NACHC P&I trip also coincided with the peak of cherry blossom season and the trees were in full bloom throughout the week.

*FHCN employee a finalist for NACHC Emerging Leader Award

At a NACHC general session highlighting civic engagement and voting rights issues, FHCN's Melissa Siegenthaler, a clinical trainer, was recognized as one of only a dozen finalists for the 2012 NACHC Emerging Leader Award, an honor bestowed four years ago on FHCN's Director of Operations Norma Verduzco. At the session, U.S. Assistant Attorney General Thomas E. "The work each and every one of you do every day is tremendously important," said Perez, who was introduced by Dr. Jack Geiger, a founding member of Physicians for Human Rights, a living legend who together with Count Gibson helped start the community health center model in America in the 1960s.

*Health tip: Get a grip

Not only is a firm handshake a sign of confidence, it may also be a barometer of your health. A researcher followed nearly 2,500 men and women for more than a decade and linked the risk of dementia and stroke to how strong their handshakes were at the beginning of the study. Having a stronger grip was associated with a 42 percent lower risk of stroke in people over age 65 compared with other study participants with flimsier grasps. What's the connection? "Vascular problems in the brain manifest themselves in a wide variety of ways" including the strength of your handshake says study author Erica Camargo, MD. "If your grip is particularly weak, it could be a sign that your overall cardiovascular health isn't in the best shape."

*New Porterville dental facility nearing completion

Work is progressing rapidly on FHCN's new 4,500-sq.-ft. dental center on the Porterville campus. The exterior of the building is now completely framed and once windows and doors are installed, interior trim and finish work will begin. The \$2 million facility – funded by tax-exempt bonds -- will feature 12 state-of-the-art dental operatories and will dramatically increase FHCN's dental capacity. When open later this summer, the new dental center will replace the existing Putnam dental site in Porterville and will also pave the way for renovation and expansion of the second floor of the Poplar Health Center. Valley Congressmen Devin Nunes and Kevin McCarthy are expected to attend the new facility's grand opening ceremony scheduled for August.

*Wait times improving

Kudos to **Woodlake** (Medical and Dental), **Cutler-Orosi** (Dental), **Three Rivers**, **Hanford** (Medical and Dental) and **Goshen**, where in March, patients experienced an average wait time of 15 minutes or less. Across the Network, all Medical sites combined recorded an average wait time of 20 minutes, mirroring figures tallied in January and February. FHCN Dental sites posted a combined average wait time of 17 minutes, the same as February 2012. In general, wait times appear to be improving across the Network: last month 58.93% of FHCN Medical patients – nearly six out of every ten — waited 15 minutes or less, a positive increase of 4.12% compared to February 2012. Dental wait times of 15 minutes or less also

improved slightly in March, ticking up to 63.63% for all Dental patients, according to the most recent report from FHCN's quality improvement specialist **Eric Medina**. "I want to add my congratulations to Woodlake Medical-Dental, Cutler Dental, Three Rivers, Hanford Medical-Dental and Goshen on your excellent wait times," said FHCN CEO Harry Foster.

*Plans coming together for Woodlake celebration, health fair

Radio Campesina will be broadcasting live from the event and this week, officials with Ruiz Foods announced the company will be donating hundreds of breakfast burritos to FHCN's pre-grand opening celebration in Woodlake, to be held May 5 – Cinco de Mayo – along with the Woodlake Health Fair, which was rescheduled last month after being rained out. Organizers of Woodlake's new Farmers Market are currently discussing holding their new event in conjunction with FHCN and the first Woodlake Farmers Market could debut at the Cinco de Mayo celebration. *CMO provides PCHH rollout update

Chief Medical Officer **Dr. Steven Palmer** provided an update this week on the progress made so far in implementing the Patient Centered Health Home model at FHCN: "Patient Centered Care means giving patients what they need when they need it," said Dr. Palmer. "As we become more of a Patient Centered Health organization, we have started by first putting patients into panels for providers and then teams. The patient then knows their team and the team knows the patient." The patient care team, Dr. Palmer explained, can determine who best to interact with a patient at a specific visit for specific needs. "This transition from patients coming in to see any available provider will take reeducating ourselves as well as the patients about what services we offer and who on the team is best equipped to handle the patient's needs at that visit."

FHCN has implemented and will continue to expand a worksite wellness program. "The idea is to work in a setting that will support the values of choosing a healthy lifestyle," says FHCN's Chief Human resources Officer Kerry Hydash. *ICD-10 Implementation date update

The Department of Health and Human Services has announced a proposed rule that would delay the implementation date for ICD-10, reports Laura VanGroningen, CPC, RCC, FHCN's Certified Coding Coordinator. The proposed rule delays required compliance by one year -- from October 1, 2013 to October 1, 2014 -- for new ICD-10 codes to be used to classify diseases and health problems. "Many provider groups have expressed serious concerns about their ability to meet the October 1, 2013 compliance date," says Van Groningen. "The proposed change would give providers additional time to prepare and test their systems to ensure a smooth and coordinated transition to these new code sets." The new codes will provide vital and specific data that will help improve patient care and the quality of information available for quality improvement and payment purposes. *Huddles working in Hanford

Karen Bennett, clinic manager in Hanford, together with community relation representative **Francisca Camarena**, marshaled all of their resources this past Sunday to produce what turned out to be a highly successful and well-attended health and safety fair. *FHCN's Kinder Care program receives additional funding

FHCN's highly successful Kinder Care dental program, which has provided more than 20,000 field screenings and free fluoride varnishes to area children up to age five and pregnant mothers, was awarded a \$368,275 grant by First 5 Tulare County late last week during a special meeting at the Board of Supervisors' chambers. The grant will fund the program until 2015. "Since we started Kinder Care three years ago, the program has provided a huge boost in helping children in Tulare County fight cavities and improve their overall oral health," said **Dr. Henry Cisneros**, who heads the program and is also FHCN's chief dental officer.

*Positive patient comments flow in from sites around the Network

Patients had high praise for FHCN team members last month. Here is a sampling of comments received: Woodlake – "Doctor Munoz (PA-C Rocio Munoz) was very courteous and treated me well." *Report: Mexican immigration to U.S. down sharply

According to report issued this week, net migration from Mexico to the U.S. has come to a statistical standstill, stalling one of the most significant demographic trends of the last four decades. Amid an economic downturn and increased enforcement at the U.S.-Mexico border, the number of Mexicans coming to the United States dropped significantly, while the number of those returning home increased sharply over the last several years, according to a report by the Pew Hispanic Center. "The largest wave of immigration in history from a single country to the United States has come to a standstill," the report says. The estimates are based on data from the U.S. Census Bureau and on Mexican census data. The most recent data indicate that the historic flow of migrants into the U.S. might even have started to reverse. "We're seeing more people moving back to Mexico than leaving for the United States," wrote the report's co-author.
