HEALTH CENTER GRAND OPENINGS

Last week Clinica Sierra Vista celebrated TWO Grand Opening/Open House events in Bakersfield and Fresno. These events were part of National Health Center Week, a week long event to raise understanding about the mission and accomplishments of America's Health Centers as local solutions for affordable and accessible health care.

On Thursday, August 22nd, we had the grand opening of the **Greenfield Community Health Center** located at 9001 South H Street, Bakersfield, CA 93301. The site began serving patients on August 19, 2013. The new facility is 10,204 square feet, has 10 exam rooms, fully equipped with an electronic health records system, and digital x-ray machine. The site provides primary care services, including family practice, internal medicine, pediatrics, and obstetrics/gynecology. The center will offer health care for all life stages through the Primary Care Medical Home (PCMH) model and the Total Patient Model, including age-appropriate immunizations, health screenings, and follow-up care for chronic diseases such as asthma and diabetes.



On Friday, August 23rd, we celebrated the grand opening and dedication of the **Elm Community Health Center-Campus** located at 2740/2760 S. Elm Ave, Fresno, CA 93706. The Elm Campus encompasses two new buildings:

- (1) Elm Community Health Center, located at 2740 S. Elm Ave, provides primary care services, including family practice and internal medicine and
- (2) the Elm Women's and Pediatric Community Health Center, located at 2760 S. Elm Ave, provides

obstetrics/genecology/ well women and pediatric/children services. The campus also has a dental center along with several ancillary program services, such as WIC, MCOP/CPSP, Behavioral Health and Patient Navigator, all in an effort to provide comprehensive care to our patients. The site has extended hours of operation, open six (6) days a week at ten (10) hours per day, totaling 60 hours per week, in order to accommodate patients who are unable to access care during a regular work week.
